¹ Arriving in Mendocino County from out-of-county for drug treatment while on parole, this recidivist defendant was charged by the District Attorney with two prior Strike convictions, meaning he was looking at a minimum state prison sentence of 25 years to life for the criminal misconduct he committed here in Mendocino County. However, Mendocino County Superior Court Judge Victoria Shanahan exercised her discretion and ordered the two prior Strike allegations dismissed “in the interests of justice.” While the “paper” state prison commitment he ultimately received without benefit of the Strike enhancements was 228 months, defendant Totten’s “real” time commitment that was left to be served -- due to the expedited release aspects of Proposition 57 -- will be no more than 72 months in state prison (minus pre-sentence credits “earned” while sitting in the Mendocino County Jail pending resolution of his case.) This outcome is not an outcome that the voters were seeking when the voters voted in favor of Proposition 36 in November 2012 and its modifications to California’s Three Strikes law.
