 - Jill has a set date to retire
- Redwood Children's Services- Victoria Kelly
 - Annual gift drive for our foster family agencies and residential homes beginning soon
 - Pushing forward a larger campaign to bring attention to the statewide insurance liability insurance crisis hitting foster family agencies and service providers
 - CSEC collaboration, bringing in a speaker, author Jesse Leon.
- Juvenile Justice and Delinquency Prevention Commission- Kate Gaston
 - We have new commissioners
 - Commission is interested in shifting the focus on delinquency prevention
- Mendocino Community Health Clinic- Cindi Condos
 - Clinic has hired more adult service providers.

 - Wrapping up rental season.
 - Willits Charter is coming up for their environmental studies program.
 - Will remodel after shutdown.
 - This year about 2300 kids came through our program.
 - Goal to have more local spots and sponsorships.
- Superintendent of Unified School District- Debra Kubin
 - Now serving for 4 yr olds in schools. After next year it will be fully implemented.
 - Currently planning for next school year.
 - Continue to partner with City of Ukiah for our after-school program and summer program
 - Now have 9-hour school days and an additional 30 school days per year.
 - Will offer spring break program again
- Probation- Izen Locatelli
 - Juvenile Hall is getting close to fully staffed.
 - Probation side is very understaffed.
 - Prop 36 is an unfunded mandate that will stretch already slim resources thin
 - Met with Lake County Juvenile Justice Commission
 - Lake County youth are back in Mendocino County Juvenile Hall full time
- First 5 Mendocino- Jade Aldrich
 - All people on Partnership Medi-Cal can now have Doulas
 - We're rolling out Triple P for babies
- North Coast Opportunities- Teri Sedrick
 - New CEO Daniel McIntire started November 1st
- BACA- Bones
 - Non-profit organization and would like to be on the agenda for a presentation in February or May
