
Notice of Nomination Period for the Board of Retirement Retired Member 8th Seat and Alternate Member 10th Seat Elections to be Held November 16, 2026

Notice is hereby given by the Mendocino County Employees Retirement Association (MCERA), pursuant to the [Board Election Policy](#), that **November 16, 2026 is hereby fixed as the date on which an election will be conducted** to elect one Retired Member and one Alternate Member to the Board of Retirement. The successful candidates will complete terms beginning December 1, 2026 and ending November 30, 2029.

- Requirements:
1. Shall be a Retired Member of the Mendocino County Employees Retirement Association.
 2. Shall submit:
 - a) Declaration of Candidacy
 - b) Candidate Statement of Qualifications (200 Words or Less)
 - c) Statement of Economic Interest (CA Form 700)

Board members need to possess the ability to fulfill the fiduciary duties required under the law to ensure that MCERA is appropriately governed and managed. The overriding goal of the Board is to serve the best interests of members and beneficiaries, and to protect the assets of the Association. The duties and responsibilities are fully described in the [Board of Retirement Charter](#). A Board member shall be available to attend regular Retirement Board meetings, usually held on the third Wednesday of each month at 8:30 a.m., special meetings held for a specific matter, and educational sessions related to Board responsibilities. In person attendance is required unless just cause or disability exception applies per the [Board Meeting Remote Attendance Policy for Trustees](#).

Declarations of Candidacy are due no later than 5:00 pm on Friday September 11, 2026.

Candidates must complete and file Candidacy Forms with the required Candidate Statement of Qualifications of 200 words or less and Statement of Economic Interest (CA Form 700) no later than 5:00 pm on September 11, 2026. Forms are available online at www.mendocinocounty.gov/retirement or by contacting MCERA at (707) 463-4328. Submit completed forms to MCERA at 625-B Kings Court, Ukiah, CA 95482 or email to retirementassociation@mendocinocounty.gov. Late submissions will not be accepted.

If by 5:00 pm on September 11, 2026 only one member has been duly nominated for each seat in accordance with the rules established for the holding of such election, the Board of Supervisors shall order that no election be held and shall cast unanimous ballots in favor of such nominated members.

If by 5:00 pm on September 11, 2026 more than one member has been duly nominated for each seat in accordance with the rules established for the holding of such election, MCERA shall distribute ballots to all eligible retired members no later than September 18, 2026. Ballots must be returned to MCERA by 5:00 pm on Friday November 13, 2026. The canvas of the votes will commence at 9 a.m. Monday November 16, 2026.
